Outcome from consultation on proposed Council fees and disciplinary levy

Thank you for considering the Medical Council of New Zealand's (Council) recent consultation on the proposed Council fees and disciplinary levy, and thanks to the individuals and organisations who made submissions.

Council received 31 written submissions from 22 individual doctors and 9 organisations. These submissions were reviewed by Council at its meeting on Tuesday 13 April 2021. After careful consideration of the feedback, Council resolved to approve:

- a. an increase to the practising certificate fee and disciplinary levy to an inflation adjustment of 0.7% overall.
- b. other proposed fees as outlined in the consultation document.
- c. the re-evaluation fee for college advice for vocational applications where the advice has not been favourable and the applicant chooses to have it reconsidered, was revised from a proposed fee of \$750 to \$1,200 excluding GST to reflect the time and work involved for colleges to re-evaluate the application.

Council acknowledged the findings of the activity-based costing review, which is important to ensure the Council's fee structure remains fair and equitable by limiting any cross subsidisation through the practising certificate fee. Council was pleased that an increase to the practising certificate fee and disciplinary levy was able to be limited to an inflation adjustment of 0.7% overall, as shown below.

A full schedule of fees payable to the Council was published in the New Zealand Gazette today and takes effect from 1 July 2021. These are also attached to this letter.

Practising certificate (PC) fee and disciplinary levy 1

The components making up the combined PC fee and disciplinary levy are set out in the following table.

Key themes of submissions

52% of responses were supportive of the proposed fee increases, including the retention fee to be charged to non-practising doctors who choose to remain on the register. 19% were against, with the

remainder indicating non-specific or unrelated responses. Many acknowledged that the proposed fee structure appeared reasonable and was based on principles of equity and fairness in relation to those activities listed in the fee schedule.

Several responders said that the proposed increase in the medical college advice fees may discourage employers (including district health boards) from recruiting positions where no suitably qualified, New Zealand based applicants exist.

In response, Council has requested that the situation is monitored to ensure the fees do not provide a barrier to international medical graduate applicants. Council was mindful that if it did not reflect the increased costs of the services of the medical colleges where they lay, then it would mean a greater increase to the practising certificate fees for all doctors.

Other responses cited concern around affordability and economic hardship due to COVID-19. Council is very aware of the need to keep our own costs under control and to minimise all of our fees at all times.

Key to annotations

- 1. All fees are non-refundable unless denoted.
- 2. Reduced fee payable for first time applicants applying for registration within a provisional or special purpose scope of practice where the appointment is for six months or less. For appointments longer than six months, the PC fee will be charged to bring medical practitioners on to their PC cycle.
- 3. Fee includes a disciplinary levy of \$201.90.
- 4. Services provided by external providers are on-charged in full by Council. A one-off administration fee is charged up front to cover the cost of Council staff time and overheads.
- 5. Fee adjusted by inflation only.
